1. Purpose

The purpose of this Scholarship: Policy & Procedure is to reach out the students from economically/socially weaker sections and differently-abled without caste or religious bias to make higher education accessible to them. Scholarship: Policy & Procedure will ensure that the Government as well as Non-Government Organisation (NGO) scholarship/freeships/financial assistance is effectively managed, administered and delivered for the betterment of students

The core idea of the institution is inclusivity and that no student should be deprived of education due to financial limitations.

2. Scope

This is a Mangoan Taluka Education Society's Doshi Vakil Arts College and G.C.U.B. Science & Commerce College, Goregaon-Raigad wide policy.

3. Definitions

- 3.1 **Management:** Management means Mangoan Taluka Education Society, Goregaon-Raigad
- 3.2 **Institute:** Institute means Mangoan Taluka Education Society's Doshi Vakil Arts College and G.C.U.B. Science & Commerce College, At-Goregaon, Tal-Mangaon, Dist-Raigad-402103
- 3.3 **Scholarship:** The students admitted belonging to the reserved category whose family income from all sources falls under the specific limit of the respective category can avail the Post Metric Scholarship under the concerned department. The benefits of the scholarship include tuition fee, examinations fee and maintenance allowances.
- 3.4 **Freeship:** The students admitted belonging to the reserved category whose family income from all sources is above the limit specified in the scholarship and is below the specific limit of the respective category can avail the Tuition Fees and Examination Fee (Freeship) under the concerned department
- 3.5 **Government Scholarships/Freeships:** Government Scholarships/Freeships refer to scholarships/freeships that are offered by the Government of India and the State Government of Maharashtra.
- 3.6 **Institutional Scholarships:** Institutional Scholarship refers to scholarships that are established by the institution from internal funds.
- 3.7 **NGO:** A non-profit organization that operates independently of any government, typically one whose purpose is to address a social issue.
- 3.8 **Collaborative Scholarships:** Scholarships that are established by external donations or sponsorship from community and industry for students of



Institute, and the application and/or disbursement process is supported by institute to some under graduate degree.

- 3.9 **Institutional Scholarships:** Scholarships that are established, managed and distributed by institution from internal funds.
- 3.10 **Student:** Student means a student enrolled in Mangoan Taluka Education Society's Doshi Vakil Arts College and G.C.U.B. Science & Commerce College, Goregaon-Raigad
- 3.11 **SC/ST/OBC/SBC/VJ/NT/Minority/EBC Welfare Committee:** It is the scholarship policy implementation Committee constituted by the Principal. It is herein referred to as Committee.

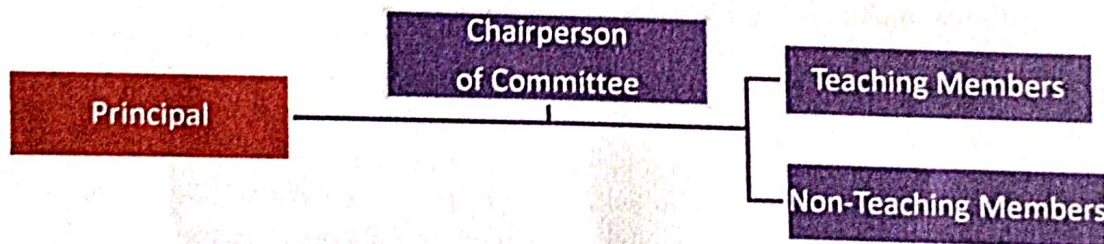
4. Policy Statement

Institute provides an opportunity for education based on principles of inclusivity, equity and transparency. Institute promotes scholarships consisting of a variety of scholarship types funded by the Government of India/community, industry stakeholders and institute. Institute ensures that the scholarships are promoted and delivered within clear and transparent guideline.

5. Responsibility

The responsibility of implementation of Scholarship: Policy & Procedure is entrusted on the Principal, Committee and Administrative office. The committee mentioned in this policy play a vital role in ensuring the successful implementation of the scholarship/freeship and financial assistance.



6. SC/ST/OBC/SBC/VJ/NT/Minority/EBC Welfare Committee

- 6.1 **Composition of Committee:** The SC/ST/OBC/SBC/VJ/NT/Minority/EBC Welfare Committee will be made up of no less than three members, with representatives from across the institution. The Review Committee will, as a



minimum, include a representative from Faculty members and administrative staff.

6.2 The objective of the Committee:

- 6.2.1 To conduct awareness, promotion and implementation programmes for students on financial assistance through scholarships, freeships, etc.
- 6.2.2 To display and circulate the information related to scholarship through banner, prospectus, pamphlets, website, social messaging and text messages.
- 6.2.3 To regulate the implementation process from receiving the applications to scrutinizing the application of the eligible student for the scholarship and also to keep record of these selected students.
- 6.2.4 To implement the circulars of scholarships from the Government of India, State Government of Maharashtra and others.
- 6.2.5 To facilitate the application process within the timeframes.
- 6.2.6 To communicate the key dates and deadlines of scholarships to students through notices.
- 6.2.7 To identify, encourage and assist the eligible students to fill the scholarship form.
- 6.2.8 To create funds for financial assistance through collaboration with the community, NGO, Industries, Social Workers, Management, etc.
- 6.2.9 To scrutinise the objective of non-Government funding agencies or donors.
- 6.2.10 To identify students with no financial assistance and to recommend them to the Principal for financial assistance.
- 6.2.11 To resolve all queries and grievances of students related to scholarships.
- 6.2.12 To maintain the records and produce whenever require.
- 6.2.13 To review and prepare the report of scholarship at end of the Academic Year.
- 6.2.14 To prepare the budget for next year for institutional financial support.

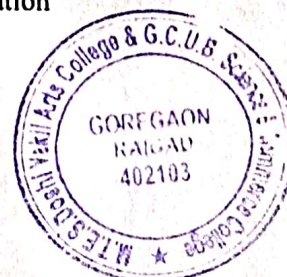

- 7.13.3.1.7 If Applicant get admission in government hostel then he will eligible only 1/3rd amount of hostlers.
- 7.13.3.1.8 For B.Ed and D.Ed courses : 100 % benefit (Tuition Fees, Exam Fees and Maintenance Allowance) is applicable for D.Ed, B.Ed courses. For students studying in Aided, UnAided for D.Ed, B.Ed courses then Fee structure is applicable as per Government rates for same course

Note : If applicant takes an admission on or before 20th of any month should entitle date maintenance allowance will be issued for that current month. Other wise maintenance allowance will be entitle from next month.

7.13.4 Eligibility

- 7.13.4.1 The parents/Guardians annual Income should be less than or equal to Rs.1.50 Lac.
- 7.13.4.2 Applicants must be belongs to SBC category.
- 7.13.4.3 Applicants should be residents of Maharashtra.
- 7.13.4.4 Applicants must be pursuing the education course approved by the government from class Post-Matric.
- 7.13.4.5 If Applicant fails in particular year then he will get the Tuition Fees, Exam Fees and Maintenance allowance of that particular academic year but he/she will not get the benefit until he/she gets promoted to next higher class.
- 7.13.4.6 Applicant should be come through CAP round for only professional courses.



- 7.13.4.7 Only two children (i) any number of girls applicants allowed. ii) boys applicants maximum 2 of the same parent will be eligible for the Scholarship.
- 7.13.4.8 No scholarship will be paid to the Applicants under this scheme from the date he /she accepts another Scholarship / stipend.
- 7.13.4.9 75 % attendance is mandatory for current year.
- 7.13.4.10 Applicant will be eligible for scholarship if he / she changes the course Non – Professional to Professional but he will not be eligible if he / she changes the course from Professional to Non – Professional.
- 7.13.4.11 Scholarships/freeship will continue until Applicant completes one course. Ex. - 11th, 12th Arts - B.A., M.A. , M.Phil., P.H.D. If, Applicant completed B.A and B.Ed. course and later after taking admission for M.A., for M.A. course He/she will not be allowed for scholarship/freeship. But after admission to M.B.A. after B.Ed, it can be eligible for scholarship/freeship as it is a professional postgraduate course.
- 7.13.4.12 Applicant studying in particular professional/Non-Professional course, and availing benefits of scholarship/freeship for that academic course and if he/she wants to change his existing Professional/Non-Professional course in between academic years he/she will not be eligible for freeship/scholarship for further course.
- 7.13.5 Renewal Policy
- 7.13.5.1 The Applicant have to pass the previous year examination.
- 7.13.5.2 In case of SBC if Applicant fails for a year then the Applicant is not paid any reimbursement for that particular year.
- 7.13.5.3 For Group A – If an applicant pursuing Group A course fails in the examination for the 1st time the award may be renewed. For second & sub sequent failure in any class the Applicant shall bear his / her own expenses until he / she secure promotion to the next higher class.
- 7.13.5.4 For Group B,C,D,E - he/she has to secure promotion to higher class(For second & sub sequent failure in any class the Applicant shall bear his / her own expenses until he / she secure promotion to the next higher class.).
- 7.13.5.5 If due to any medical condition or due to any unforeseeable event the Applicant cannot appear in the annual examination, the head master of the college can approve or certify that if the Applicant would have appeared in the annual examination, he would have been able to pass the examination. This will be only allowed if the head of the institution is satisfied by the submission of medical proof or any other required sufficient proof that the Applicant presents to the college.
- 7.13.6 Documents Required
- 7.13.6.1 Caste certificate - should be issued by competent authority(Issued by Govt. of Maharashtra) This certificate considered as Proof of Resident.



- 7.13.6.2 Income certificate / Income Declaration - should be issued by competent authority
- 7.13.6.3 Caste Validity Certificate – (Mandatory for Professional Degree courses, Professional Post Graduate. For Non Professional courses caste validity is not mandatory)
- 7.13.6.4 HSC or SSC marksheet or last examination marksheet.
- 7.13.6.5 Gap certificate - Not mandatory but in case of gap it is mandatory.
- 7.13.6.6 If applicable father/Guardians death certificate.
- 7.13.6.7 Ration Card for identify number of children in family.
- 7.13.6.8 Leaving Certificate
- 7.13.6.9 Declaration certificate of parents/guardians about number of children beneficiaries.

7.14.2 Overview

- 7.14.2.1 Create interest in education among students.
- 7.14.2.2 Making financial assistance available for higher education.
- 7.14.2.3 Creating opportunities for financial growth through higher education.
- 7.14.2.4 Scholarship scheme to avoid transparency, unity and delay.
- 7.14.2.5 All types of compulsory fees such as Tuition fees, Exam Fees and other admissible fees are reimbursed to the concern SBC category student.

7.14.3 Benefits

- 7.14.3.1 Tuition fees and Exam fees reimbursed to the concern Applicant vide Govt. Resolution dated 12/3/2007, since 2006-07 the Applicants who are admitted in professional courses through CAP round in the Govt., Govt. approved private, non-aided and permanently non granted colleges are applicable to pay 100 % Tuition Fees & Exam Fees approved by Education Fee Committee.
- 7.14.3.2 Also those applicants are taken admission in Deemed University for professional courses won't get benefit of scholarship / freship.
- 7.14.3.3 Start date of application is depending upon the applicant takes admission in college/Institute and End date of application is depend upon the last date of examination. (For 10 months - it will vary every academic year on admission date)

7.14.4 Eligibility

- 7.14.4.1 Applicant must be taking post matric education.
- 7.14.4.2 Parent's annual income should be less than or equal to 8.00 Lacs.
- 7.14.4.3 Applicant should be belongs to SBC Category.
- 7.14.4.4 Applicants must be residents of Maharashtra.
- 7.14.4.5 Applicants must be pursuing the education course approved by the government for Post Matric courses.



7.14.4.6 Applicant should be taken admission in government government aided / Private Non-Aided / private permanently non aided courses.

7.14.4.7 Degree Courses in Health Science(Medical, Dental, Homeopathy, Unani, Ayurveda, Physiotherapy, Business Aid, Nursing) :

7.14.4.8 If Applicant is admitted through Association of Managements of Unaided Private Medical and Dental Colleges entrance examination or admitted through government common entrance examination then he/she will be eligible the for the freeship.

7.14.4.9 Higher and Technical Education Department:

7.14.4.10 Freeship will be applicable to unaided colleges / government and aided colleges with technical education / Polytechnic and government unaided professional courses.

7.14.4.11 Following are the applicable courses for this scheme:

Diploma – Engineering, Pharmacology, HMCT

Degree – Engineering, Pharmacology, HMCT

Post Graduate –MBA/MMS, MCA

7.14.4.12 Agriculture, Animal Husbandry and Dairy Development and Fisheries Department:

The scholarship fees will be applicable to the Applicants who have been admitted through government quota in private un aided/permanently un aided institute.

- ◆ Agricultural colleges (diploma)
- ◆ Dairy Business Department (Diploma)
- ◆ Colleges for Agricultural and Allied subjects (Degree and Post Graduate)
- ◆ Agriculture and Bio-Technology Colleges (Degree and Post Graduate)
- ◆ Agriculture and Food Technology Colleges (Graduate and Post Graduate)

7.14.4.13 For B.Ed and D.Ed courses : 100 % benefit (Tuition Fees, Exam Fees) is applicable for D.Ed, B.Ed courses. For students studying in Aided, UnAided for D.Ed, B.Ed courses then Fee structure is applicable as per Government rates for same course.

7.14.4.14 For professional courses Applicant should admitted through CAP round is must.

7.14.4.15 If Applicant fails in particular year, then he will get the Tuition Fees and Exam Fees of that particular academic year but he/she will not get the benefit until he/she gets promoted to next higher class.



- 7.14.4.16 Applicant will be eligible for scholarship if he / she changes the course Non – Professional to Professional but he will not be eligible if he / she changes the course from Professional to Non – Professional.
- 7.14.4.17 If an applicant pursuing professional course admitted for year 2015-16 onwards fails in the examination two or more times in particular academic course duration, then he / she not eligible for the freeship.
- 7.14.4.18 Scholarships/freeship will continue until Applicant completes one course. Ex. - 11th, 12th Arts - B.A., M.A., M.Phil., P.H.D. If, Applicant completed B.A and B.Ed. course and later after taking admission for M.A., for M.A. course He/she will not be allowed for scholarship/freeship. But after admission to M.B.A. after B.Ed, it can be eligible for scholarship/freeship as it is a professional postgraduate course.
- 7.14.5 Renewal Policy**
- 7.14.5.1 Applicant need to provide previous years marksheet.
- 7.14.5.2 At a time, Applicant can apply freeship for only one educational course and it will be applicable till he/she completes that educational course in specified time.
- 7.14.5.3 Applicant need to pass each year of the specified educational year[In case of failure in a particular year he/she won't be provided reimbursement of tuition fees, Exam fees for that year]. In any academic course maximum of 2 failures is allowed.
- 7.14.5.4 Applicant cannot take freeship for more than 2 professional courses.
- 7.14.5.5 If due to any medical condition or due to any unforeseeable event the Applicant cannot appear in the annual examination, the head master of the college can approve or certify that if the Applicant would have appeared in the annual examination, he would have been able to pass the examination. This will be only allowed if the head of the institution is satisfied by the submission of medical proof or any other required sufficient proof that the Applicant presents to the college.
