





The College shall be represented by the Principal. Further Shri. Bhupendra Nathuram Sheth shall share the piece and parcel of land with survey number 56/34/62/ਕ/ਨਿੱਟ ਜਂ./15 and the total area is 585 sqm. to the college for the sport activities.

Have both the parties agreed as follows;

Article I Objective

The objective of this Memorandum of Understanding is to develop educational cooperation for the cause of Education and mutual benefits by way of providing the playground for various sports programme to be organized by the College.

Article II Areas of Cooperation

As per the Memorandum of Understanding, Shri. Bhupendra Nathuram Sheth will extend its cooperation by way of providing its playground for conduction of various sports activities of the college.

Article IV Implementation

The implementation of above said cooperation activities within the terms of this Memorandum of Understanding shall be the subject of specific arrangements concluded between the parties on the basis of and within the provision of present Memorandum of Understanding.

Article V Relinquish

Always it is open to revamp this Memorandum of Understanding in the interest of both the parties and students, concerning to the interpretation of implementation of this Memorandum of Understanding through consultation and negotiation by the parties. Even if both the parties desire to withdraw this Memorandum of Understanding, they can do so, by due process through mutual understanding.

Article VI Commencement, Duration, and Termination

This Memorandum of Understanding shall remain in force for a period of 11 months with mutual consent. The College is to be paid of Rs. 101/- (One Hundred One Rupees only) for MoU to Shri. Bhupendra Nathuram Sheth. This Memorandum of Understanding will take effect from the date of its signing. The either Party notifies in writing of its intention to terminate this Memorandum of Understanding one week in advance or by mutual consent.
